It was discussed at the December 5, 2024, Committee meeting that external candidates could be included in the search for an Interim ED. The Attorney General's Office confirmed that Committee members can reach out to candidates and solicit letters of interest. The Committee decided to extend the search time and include external candidates. The deadline for letters of interest will be December 27, 2024, and the Committee will meet again on January 2, 2025.

### PERMANENT EXECUTIVE DIRECTOR SELECTION PROCESS:

Ms. Murtha shared that Mr. Skor, Chief Financial/Operations Officer, has also submitted his resignation and his last day will be January 3, 2025. Staff recommend that the CFO/COO position be included in the executive search when the RFP for a search firm is issued. The Committee agreed that the CFO/COO position should be included in the RFP.

Ms. Murtha shared that Ms. Kmetz has agreed to be the Interim CFO/COO until the position is filled.
